Editorial policy: The Journal was the first international journal of Comparative Economics in Japan, which was published by the Japanese Society for Comparative Economic Studies (JSCES). This society is Japan's leading independent academic association and has published a leading Japanese academic journal "Comparative Economic Studies" for over 20 years and has published a new journal in English from 2003. The journal focuses on the comparative analysis of the economic systems, enterprises and industries, and the economics of transition and institutional development. The journal publishes articles of theoretical studies and empirical analyses. The journal will collaborate in the organization of conferences and regular seminars of the JSCES. The journal will include academic articles, reviews of new books and the academic information on Comparative Economic Studies in Japan. All articles and others will be refereed by the editorial board. Articles are accepted for publication subject to the condition that they have not already been published elsewhere.

Submission of manuscripts:

1. The journal will be published on an annual basis.
2. Papers may be written in English in principle.
3. Papers may be submitted electronically or in hard copy. The editorial office prefers electronic submission. For electronic submission, please submit the paper in the original format and as a PDF

file. Please check that your PDF document is readable on a computer. Submit to the paper to [mizobata@kier.kyoto-u.ac.jp](mailto:mizobata@kier.kyoto-u.ac.jp).

4. For hard copy submission manuscripts should be submitted to the Editorial Office, the Japanese Society for Comparative Economic Studies (JSCES), Prof. Satoshi Mizobata, Kyoto Institute of Economic Research, Kyoto University, Yoshidahon-machi, Sakyo-ku, Kyoto Japan, 606-8501. Tel:+81 (0)75-753-7144/7140; fax:+81 (0)75-753-7148; e-mail: [mizobata@kier.kyoto-u.ac.jp](mailto:mizobata@kier.kyoto-u.ac.jp). Four copies of typescripts should be submitted, double-spaced throughout and typed clearly on one side of the paper only. Each paper should include on a separate covering sheet the number of words and the author's name, title, current address, e-mail address, telephone and fax numbers.

5. A paper should be preceded by a brief abstract of approximately 100 words, keywords, and JEL classification numbers. Manuscripts should not normally exceed 10,000 words including tables, figures and footnotes.
